1. The Venetian Resort Las Vegas September Cash Game Promotions consist of the September Random Seat Giveaway and the September Drawing Promotion (collectively "September Cash Game Promotions"), and are for all contributing Texas Hold 'em Poker Games.
2. Participating games include any Texas Hold 'em game, Limit or No Limit that is not a part of a Mix game and does not have a time collection for rake.
3. The September Cash Game Promotions are subject to The Venetian Poker Rewards Terms and Conditions and Grazie® Terms and Conditions.
4. The Venetian Management reserves the right to cancel the September Cash Game Promotions, amend the September Cash Game Promotion rules, change the September Cash Game Promotion dates, or adjust the September Cash Game Promotion structures in its sole and absolute discretion without prior notice.
5. September Cash Game Promotion winnings are non-refundable and non-transferrable.
6. The Venetian Management reserves all rights. All disputes and subsequent decisions by Management are final and binding.
7. Failure to adhere to The Venetian September Cash Game Promotion rules will result in disqualification and/or forfeiture of any winnings.
8. September Cash Game Promotion winnings will be paid from a promotional pool funded by The Venetian Bad Beat Jackpot ("Promotional Pool"). See The Venetian Bad Beat Jackpot Rules for details.

SEPTEMBER RANDOM SEAT GIVEAWAY

1. Beginning September 1 through September 30, 2019, ("Designated Dates") each day, beginning at 12:00 p.m., The Venetian Poker Room will randomly select one qualifying player from the list of qualifying players. Upon the completion of the current hand, the selected qualifying player will be awarded \$600 in Casino Chips ("Random Seat Giveaway"). This will continue every 30 minutes until the last Random Seat Giveaway at 12:00 a.m.
2. A qualifying player is an active player in a participating game who has no missed blind buttons, is logged in with a Grazie card, and is present at the table at the time of the random selection. If a player has not yet played a hand at their current table, has a missed blind button, is not present at the time of the random selection, or is not logged in with a Grazie card, that player will not qualify for the \$600 Random Seat Giveaway.
3. Grazie members are responsible for ensuring they are logged in to the table and are not logged in lobby in the Bravo system, in order to participate in the Random Seat Giveaway.
4. Players who are not logged in with a Grazie card, or are logged in lobby in the Bravo system (denoting that the player has a missed blind button), will not be included in the random draw.
5. In the event that a player, who is not a qualifying player, is randomly selected, a new random selection will take place until a qualifying player is randomly selected.
6. The Venetian Poker Room Management reserves the right to refuse payment to an otherwise qualified player based on excessive absenteeism from the table.
7. Winners are permitted to add any portion of the Random Seat Giveaway to their current chip stack when they receive their Random Seat Giveaway. Once one (1) hand is played after receiving their Random Seat Giveaway, standard table stakes rules apply.
8. Winners must present valid ID and a Grazie card to collect their Random Seat Giveaway. The Random Seat Giveaway will be forfeited if Winner refuses to provide valid ID and a Grazie card. Forfeited Random Seat Giveaways will remain in the Promotional Pool.
9. If Winner is willing but unable to produce valid ID and a Grazie card at the time of the random selection, he or she will have seven (7) days to claim the Random Seat Giveaway at the Poker Room Cage. Random Seat Giveaway will be forfeited if Winner does not provide valid ID and Grazie card within 7 days. Forfeited Random Seat Giveaways will remain in the Promotional Pool.

SEPTEMBER DRAWING PROMOTION

1. The September Drawing Promotion is effective September 1, 2019 at 4:00 a.m. through October 1, 2019, at 3:59 a.m. ("Promotional Period").
2. Grazie members earn drawing tickets based on total active cash game play in participating games at The Venetian Poker Room during the Promotional Period ("Active Play").
3. Hours of Active Play are tracked through use of a Grazie card. Players who play without using a Grazie card will not have their Active Play tracked. Grazie members are responsible for using Grazie card to ensure Active Play is tracked.
4. Grazie members are responsible for ensuring they remain logged into the table and for verifying the accuracy of their play. At the completion of the Promotional Period, each Grazie member's Active Play will be calculated from September 1, 2019 at 4:00 a.m., through October 1, 2019 at 3:59 a.m. If a Grazie member earns 100 to 199 hours of Active Play, that Grazie member will receive one (1) drawing ticket. If a Grazie member earns 200 or more hours of Active Play, that Grazie member will receive five (5) drawing tickets.
5. A list of qualifying Grazie members, and drawing tickets earned, will be posted in The Venetian Poker Room by October 7, 2019.
6. All drawing tickets will be distributed October 9, 2019, between 5:00 p.m. and 7:00 p.m. in The Venetian Poker Room. Participating Grazie members must claim drawing tickets in person, and sign confirming receipt of all drawing tickets. The participants are responsible for immediately placing their drawing tickets into the drawing drum.
7. On October 9, 2019 at 8:00 p.m., a random drawing will be held from all of the drawing tickets in the drawing drum. Twenty (20) drawing tickets will be randomly selected ("Drawing"). The Grazie members whose drawing tickets are randomly selected will each win five thousand dollars (\$5,000), to be paid from the Promotional Pool ("Prize"). Grazie members are limited to one (1) Prize.
8. Winners must be present at the time of the Drawing, must provide a valid ID and The Venetian Grazie Card at the time of the Drawing, and will be subject to federal guidelines for 1099 or 1042S reporting. Should the Winner not be present at the time of the Drawing, have already won a Prize, not have valid ID, or The Venetian Grazie card at the time of the Drawing, refuse the Prize, or refuse to fill out reporting paperwork at the time of the Drawing, then that Winner will forgo the Prize, and another Drawing will be held immediately to determine a new Winner.
