



THE 24 HOUR FEBRUARY MYSTERY HIGH HAND AND 2 FOR 2 BONUS ENVELOPE GIVEAWAY RULES

1. The Venetian 24 Hour February Mystery High Hand and 2 for 2 Bonus Envelope Giveaway is for all contributing Texas Hold 'em Poker Games.
2. Participating games include \$1-\$3 and \$2-\$3 No Limit Hold 'em games and \$4-\$8 and \$8-\$16 Limit Hold 'em games that are not a part of a Mix game and does not have a time collection for rake.
3. Beginning February 1 at 12:00 p.m. through midnight on February 28, 2026 ("Designated Dates"), The Venetian Poker Room will award the player with the highest qualifying hand in any participating game a Mystery High Hand Giveaway prize valued between \$100 and \$20,000. The Qualifying Period will begin at 12:00 p.m. on February 1 and continue every thirty (30) minutes until 12:00 a.m. on March 1, 2026 ("Qualifying Periods"). The first player to achieve the highest hand in each Qualifying Period will have a chance to select a Mystery High Hand Giveaway envelope from our drawing drum located inside The Venetian Poker Room ("Giveaway"). The Qualifying Period and hands reset every 30 minutes. The last Qualifying Period will be from 11:30 p.m., and the final Giveaway prize will be at 12:00 a.m. on March 1, 2026.
4. All registered qualifying Venetian Rewards members from February 1 through February 28, 2026, who participate in the Mystery High Hand Giveaway, who have the highest hand in any given Qualifying Period, will select one of one thousand nine hundred sixty eight (1,968) Mystery High Hand Giveaway envelopes from the drawing drum. Mystery High Hand Giveaway cash prizes will be as follows:

\$20,000 – two (2) possible winners
\$10,000 – four (4) possible winners
\$5,000 – eight (8) possible winners
\$2,000 – eight (8) possible winners
\$1,000 – eight (8) possible winners
\$500 – twenty two (22) possible winners

\$175 – four hundred (400) possible winners
\$150 – five hundred (500) possible winners
\$125 – five hundred (500) possible winners

Total Mystery High Hand Giveaway Prize Pool of \$437,300

Two \$1,000, \$2,000, \$5,000, and one \$10,000 Mystery High Hand Giveaway cash prize envelopes will be placed into the Drawing Drum each week on the following schedule:

Two each of \$1,000, \$2,000, and \$5,000 envelopes and one \$10,000 cash prize envelope
– February 1, 2026

Two each of \$1,000, \$2,000, and \$5,000 envelopes and one \$10,000 cash prize envelope
– by 1:00 p.m. on February 8, 2026

Two each of \$1,000, \$2,000, and \$5,000 envelopes and one \$10,000 cash prize envelope
– by 1:00 p.m. on February 15, 2026

Two each of \$1,000, \$2,000, and \$5,000 envelopes and one \$10,000 cash prize envelope
– by 1:00 p.m. on February 22, 2026

The \$20,000 grand prize envelopes will consist of \$10,000 in cash and \$10,000 as a buy in prize to play on our Venetian Poker Live High Stakes No Limit Hold 'em cash game stream with Michael "The Grinder" Mizrahi. Future monthly stream dates in 2026 are to be determined. Winner must play on the High Stakes No Limit Hold 'em monthly Michael "The Grinder" Mizrahi cash game stream of their choosing before June 1, 2026, to be awarded the \$10,000 buy in prize. Seats are non-transferable. If Winner is unwilling or would like to choose not to play in the High Stakes No Limit Hold 'em cash game stream with Michael "The Grinder" Mizrahi, the Winner may choose to receive the full \$20,000 cash prize instead.

One \$20,000 grand prize envelope will be placed in the drawing drum on February 1, 2026, and the other \$20,000 grand prize envelope will be placed into the drawing drum on February 15, 2026.

All registered qualifying Venetian Rewards members from 12:00 a.m.-12:00 p.m. who participate in the 24 Hour February Mystery High Hand and 2 for 2 Bonus Envelope Giveaway, who have the highest hand in any Qualifying Period from 12:00 a.m. until 12:00 p.m. daily, who have at least 2+ hours of active ongoing play time at the time of the Qualifying Period ending, for which the patron had the qualifying high hand, will select a Mystery High Hand and Bonus envelope from the Drawing Drum (Two (2) Total Envelopes). Both envelopes must be drawn at the conclusion of the Qualifying Period. Lobby time does not count towards active play time. It is the patron's responsibility to ensure they are logged in at all times. Players who are not logged in will not have their hours tracked for terms of active cash play time.
6. On Sunday, February 8, 2026 all Mystery High Hand cash prize envelopes drawn from the Drawing Drum will automatically double (x2) the prize amount. This means that someone has the chance to win a \$40,000 Mystery High Hand Giveaway cash prize. This double (x2) Mystery High Hand payout is good for all Qualifying Periods from 12:00 p.m. until the 7:00 p.m. Mystery High Hand Draw on Sunday, February 8, 2026, only.

VENETIAN POKER

7. Winner is permitted to add any portion of the Giveaway to their current chip stack. Once one (1) hand is played after Winners receive their Giveaway, standard table stakes rules apply.
8. To qualify for the Giveaway, a player must show a hand that is stronger than the currently posted High Hand. Only a full house or higher will qualify. The current qualifying hand will be announced and/or posted.
9. To be considered part of a Qualifying Period, a qualifying hand must be tabled by the player, and the hand must be complete prior to that Qualifying Period ending. Otherwise, if applicable, the hand will be considered part of the next Qualifying Period.
10. It is the player's responsibility to alert the dealer of a qualifying High Hand during any Qualifying Period. Any potential High Hand that is not brought to the attention of the dealer or a supervisor during the Qualifying Period for which the hand was tabled will result in that High Hand being null and void. The player who had the potentially winning High Hand will forfeit any portion of the Mystery High Hand Giveaway for the Qualifying Period in dispute.
11. Any player who is deemed by poker management to intentionally stall playing their hand in order to progress their potential high hand to the next Qualifying Period leaderboard may have their potential high hand disqualified, may be asked to leave the poker room for the day, and may have their playing privileges revoked altogether. These concerns should be brought forth by players to poker management in real time so we can investigate, monitor, and resolve as needed to protect the integrity of the promotional pool.
12. There must be a minimum of four players dealt in at the beginning of the hand in order to qualify for the Giveaway.
13. A qualifying hand can use any five-card combination, provided they use both cards in their hand. It does not need to be the best five-card hand. The player must win the entire main pot for which the qualifying hand was dealt.
14. Giveaways will be paid from a Promotional Pool funded by The Venetian Promotional Progressive Pots and Pools, Drawings, and Giveaway Programs Rules ("Promotional Pool"). During the 24 Hour February Mystery High Hand and 2 for 2 Bonus Envelope Giveaway, the Promotional Fund drop per hand will be \$1 on the flop, with a second \$1 taken if/when the pot reaches twenty (\$20) total. In the event that there are no qualifying hands during a Qualifying Period, then there will be no Winner, and as a result, any Mystery High Hand cash envelope prizes not drawn at the conclusion of the 24 Hour February Mystery High Hand and 2 for 2 Bonus Envelope Giveaway will remain in the Promotional Pool.
16. Winner must be present at the conclusion of the Qualifying Period, and the selection of the Mystery High Hand envelope from the Drawing Drum must be completed by the Winner at that time.
