



## THE VENETIAN SUIT OF THE MONTH PROMOTION RULES

1. The Venetian Suit of the Month Promotion is for all contributing Texas Hold 'em Poker Games.
2. Participating games include \$1-\$3 and \$2-\$3 No Limit Hold'em games and \$4-\$8 and \$8-\$16 Limit Hold'em Games that are not a part of a mix game and does not have a time collection for rake.
3. Beginning January 1 through December 31, 2026, ("Designated Dates") each day, The Venetian Poker Room will award any player who flops a straight flush using The Venetian Suit ("Suit") of the Month in any participating game a Giveaway of \$500. Any player who turns or rivers a straight flush using the Suit of the Month in any participating game will be awarded a Giveaway of \$250 (along with the above Giveaway of \$500, each a "Giveaway").
4. Winner is permitted to add any portion of the Giveaway to their current chip stack. Once one (1) hand is played after Winners receive their Giveaway, standard table stakes rules apply.
5. To qualify for the Giveaway, a player must utilize both hole cards in their hand, both of which are the Suit of the Month when making a straight flush. The Suit of the Month is as follows:

January:	Clubs
February:	Diamonds
March:	Hearts
April:	Spades
May:	Clubs
June:	Diamonds
July:	Hearts
August:	Spades
September:	Clubs
October:	Diamonds
November:	Hearts
December:	Spades

The Suit of the Month is active from 4:31 a.m. on the 1st of every month through 4:30 a.m. on the 1st of the following month. At 4:31 a.m. on the 1st, the Suit of the Month will update to the next Suit.

6. A minimum of four players dealt in at the beginning of the hand, with any hand going to the flop, qualifies for the Giveaway.
7. A qualifying hand is a straight flush, provided the player utilizes both hole cards, both of which are the Suit of the Month in their hand. A royal flush is considered the highest straight flush and is eligible for the straight flush Giveaway.
8. During the Suit of the Month Promotion, the Promotional Fund drop per hand will be two (\$2) dollar maximum per hand. One (\$1) dollar will be taken on the flop, with the second (\$2) dollar taken if/when the pot reaches twenty (\$20) dollars.
9. Giveaways will be paid from a promotional pool funded by The Venetian Promotional Progressive Pots and Pools, Drawings, and Giveaway Programs Rules ("Promotional Pool"). See The Venetian Promotional Progressive Pots and Pools, Drawings, and Giveaway Programs Rules for details.
10. Winners must present a valid ID and a Venetian Rewards card to collect Giveaway. Giveaway will be forfeited if Winner refuses to provide a valid ID and a Venetian Rewards card. Forfeited Giveaways will remain in the Promotional Pool.
11. If Winner is willing but unable to produce a valid ID and a Venetian Rewards card, Winner will have seven (7) days to claim the Giveaway at The Venetian Poker Room Cage. Giveaway will be forfeited if Winner does not provide a valid ID and Venetian Rewards card within seven (7) days. Forfeited Giveaways will remain in the Promotional Pool.
