



VENETIAN REWARDS

RULES

1. Participation is complimentary and at the sole and absolute discretion of Venetian Las Vegas Gaming, LLC ("The Venetian").
2. Participants must be at least 21 years of age and a Venetian Rewards Member to participate in the A Cut Above the Rest Kiosk Promotion or any of its functions ("Promotion").
3. SCA Promotional Kiosks ("Kiosk") are owned and operated by SCA Gaming. SCA Kiosks offer kiosk-based promotional games.
4. The Promotion is valid July 25, 2024 – September 1, 2024.
5. Participants have the opportunity to earn one (1) entry for every 1,200 Venetian Rewards Points earned while playing slots during the Promotion Earning Period ("Earning Period").
6. Points earned from Experiential Spend, Slot Multipliers and Electronic Table Games (ETG) are excluded from this Promotion.
7. Earning Period begins at 4:30 a.m. on Thursday July 25, 2024, and ends at 11:59 p.m. on Sunday, September 1, 2024.
8. Participants can earn and redeem up to 5 entries per day during the Earning Period.
9. Any accrued points over the 5 maximum entries per day will continue to carry over for use until the end of the Promotion.
10. Participants may redeem their entries at the Kiosks located at either Venetian Rewards Desk during operational hours. Desk operational hours are 8:00 a.m. through 1:00a.m. Sunday through Thursday and 8:00 a.m. through 2:00 a.m. on Friday and Saturday during the Earning Period.
11. The participant must swipe their Venetian Rewards Card at the Kiosk where they will be prompted to hit the start play button. Participant will select and reveal prizes behind the gem icons until two matching prize values are revealed. That prize amount will be awarded in Slot Credits. If participant has earned multiple entries, they will continue to play each entry until they run out or they hit the maximum of 5 per day.
12. A receipt will be printed with the prize amount from the Kiosk and must be redeemed by the Participant within 24 hours of issuance, or prize will be void. Participants must redeem their prize at the Venetian Rewards Desk during operational hours
13. Receipts are non-transferable, either voluntarily or by operation of law, and lost or stolen receipts will not be reissued.
14. Slot credits will expire at 11:59 p.m. on September 8, 2024.
15. Cash prizes must be claimed at The Palazzo Casino Cage within forty-eight (48) hours. Failure to do so will result in forfeiture of prize.
16. Disposition of the winnings and payment of applicable taxes are the responsibility of the Participant.
17. Kiosk malfunction of any kind voids all pays and plays.
18. If for any reason a participant's play is confirmed to have been erroneously deleted, lost or otherwise destroyed or corrupted. Participant's sole remedy is another entry into the Promotion.
19. In the event any portion of the Promotion is compromised by a virus, bugs, non-authorized human intervention, hackers or other causes beyond the control of SCA Gaming or The Venetian which, in the sole

opinion of SCA Gaming, corrupts, or impairs the administration, security, fairness, or proper play of the game, SCA Gaming or The Venetian may suspend or terminate all or part of the Promotion.

- 20. Tampering with the SCA software or the game Kiosk is strictly prohibited.
- 21. Venetian Rewards Cards must be properly inserted into the eligible games for Venetian Rewards Points to be calculated accurately. The Venetian is not responsible for the improper use of Venetian Rewards Cards. Any slot play outside of the Earning Period will not be applied towards this Promotion.
- 22. One (1) participant per Venetian Rewards account.
- 23. Participants are responsible for correctly inserting or reinserting his/her Venetian Rewards card into the slot or video machines at the start of play. If guest has opted into cardless play, it is the Participant's responsibility to activate the cardless play feature.
- 24. All Rewards Points must be earned on a participant's Venetian Rewards card and may not be adjusted or credited. Rewards Points are not transferable between accounts.
